

Report on treasury shares purchase program

Reggio Emilia, 8 July 2019 – Iren, following the announcement on 13 May 2019 concerning the launch of the share buyback program authorized by the Shareholder meeting of 5 April 2019, announces that has purchased, in the period from 1 to 5 July 2019, no. 26,928 of its treasury shares at an average price per share equal to 2.663 euro, for an aggregate amount of 61,026.93 Euro.
